All fees are fixed by the Board of Directors and may be changed as necessary. I understand that I may resign from the CLUB any time after being accepted as a member by submitting a letter of resignation to the Board of Directors. My security deposit will be refunded, less any outstanding charges due to CLUB within 12 (twelve) months after acceptance by the Board of Directors. I understand that the time between resignation acceptance and return of my deposit may be changed by the Board of Directors. I understand that among other things the Security Deposit is to guarantee payment of any accidental damage to CLUB aircraft while under my control and not covered by insurance. I understand that my limit of liability to the CLUB for any damage is \$500.00.
